## Recycling Equipment Grant

Nebraska Recycling Council’s recycling equipment grants support projects that provide public and environmental benefits to enhance or help create new opportunities for recycling programs across Nebraska.

### Who May Apply

Nebraska organizations eligible for grant funds include schools, municipalities and other government entities, nonprofit organizations, and recycling companies, recycling centers, and haulers.

### Requirements & Limitations

- Up to \$25,000 in equipment can be funded over a two-year period per organization.
- The deadline for submission of grants is the 15th of each month.
- Applicants must have been in business a minimum of 2 years.
- Applicant must be in compliance with the Nebraska Department’s laws, regulations, and permits.
- Equipment purchased before grant approval is not eligible for funding.
- A cash match of 20% - 50% is required from all grantees, depending on size of community or type of entity (e.g. business or nonprofit).
- Grant recipients are required to submit 24 months of recycling data after obtaining the grant equipment.
- Maintain insurance for the useful life of the equipment for awards over \$5,000.

### Examples of Eligible Equipment

- Forklifts, skid loaders, balers, recycling trailers, recycling carts, indoor and outdoor recycling bins, cargo trailers, semi-trailers, compost turners, dumpsters, trucks, portable loading ramps, approved recycling labels, and more.
- Equipment may be new, used, or in need of refurbishing.

## Applying for a Grant

To be considered for a recycling equipment grant, a grant application must be completed with all required attachments and signed. This is a reimbursement grant, so applicants must be financially able to purchase the equipment prior to disbursement of grant funds. Applications are accepted continuously and are reviewed after the 15th of every month.
